



## Limited Warranty – Photovoltaic Modules

### Limited product warranty:

Solarland warrants the solar modules to be free from defects in materials and workmanship under normal application, installation, usage and service conditions. If the solar modules fail to conform to this warranty, then for a period ending 24 months from date of sale to the original end-customer, the Seller at its option, either repair or replacement or refund, or refund the purchase price as paid by the Customer [" purchase price "].

Note; ...**portable solar panel products\*** are warranted for a period of 12 months from date of sale to the end-user.

### Limited peak power warranty

Solarland guarantees for a period of 10 years from the date of sale to the original consumer that the output power of the PV module (at standard test conditions) will remain at 90% or greater of the Solarland Minimum Specified Peak Power Rating.

Solarland guarantees for a period of 25 years from the date of sale to the original consumer that the output power of the PV module (at standard test conditions) will remain at 80% or greater of the Solarland Minimum Specified Peak Power Rating.

Solarland will, at its own discretion, replace such loss in power either by replacing the defective PV modules or by refunding the Purchase Price – Provided that the loss in power is due to defects in materials and/or workmanship under normal installation, application and use.

Solarland Minimum Specified Peak Power Rating is defined in Solarland product datasheets at the time of shipping. Standard test conditions are: ...irradiance of 1000 W/m<sup>2</sup>; 25°C cell temperature and AM 1.5 light spectrum.

The limited warranties set forth herein do not apply to any module which in Solarland's sole judgment has been subjected to misuse, neglect or accident; has been damaged through abuse, alteration, improper installation or application; or negligence in use, storage,

transportation or handling; or has in any way been tampered with or repaired by anyone other than Solarland or its agent.

The limited warranty does not include costs associated with module installation, removal, testing, packaging, transportation, or reinstallation; other costs associated with obtaining warranty service; or costs, lost revenues or lost profits associated with the performance or non-performance of defective modules.

Replacement modules from Solarland under a warranty claim will be subject to the same warranties and original term as the first product purchased under said claim. The term shall not be prolonged or reset from the date of sale to the original consumer purchaser. All replaced parts or products become the property of Solarland.

These limited warranties apply only to the first end-user purchaser of the modules or to any subsequent owners of the original building or site where the modules were first installed. The limited warranties set forth herein are expressly in lieu of and exclude all other express and implied warranties.

Solarland will have no responsibility or liability whatsoever for damage or injury to persons or property, or for other loss or injury resulting from any cause whatsoever arising out of or related to the product, including, without limitation, any defects in the module, or from use or installation. Under no circumstance shall Solarland be liable for incidental, consequential, or specified damages, however caused.

Solarland's aggregate liability, if any, in damages or otherwise, shall not exceed the payment, if any, received by seller for the unit of product or service furnished or to be furnished, as the case may be, which is the subject of claim or dispute. Some jurisdictions do not allow limitations on implied warranties or the exclusion or limitation of damages, so the above limitations or exclusions may not apply to you.

If a part, provision, or clause of terms and conditions of sale, or the application thereof to any person or circumstance is held invalid, void, or unenforceable, such holding shall not affect and leave all other parts, provisions, clauses, or applications of terms and conditions remaining, and to this end the terms and conditions shall be treated as severable.

This warranty gives you specific legal rights; and you may have other rights that vary from state to state and country to country. Neither party shall be in any way responsible or liable to the other party, or to any third party, arising out of non-performance or delay in performance of terms of conditions of sale due to acts of God, war, riot, strikes, unavailability of suitable and sufficient labor, and any unforeseen event beyond its control, including, without limitations, any technological or physical event or condition which is not reasonably known or understood at the time of sale.

Any claim or dispute regarding these warranties shall be governed by and construed in accordance with the laws of the State of New Jersey (US).

#### **Obtaining Warranty Performance**

If you feel you have a claim covered by warranty, you must promptly notify the dealer who sold you the module for the claim. The dealer will give advice handling the claim. If further assistance is required, write Solarland for instructions.

The customer must submit a written claim, including adequate documentation of module purchase, serial number, and nature of product failure. Solarland will determine in its sole judgment the adequacy of such claim. Solarland may require that product subject to a claim be returned to the factory, at the customers expense. If said product is determined to be defective and is replaced but not returned to Solarland, then the customer must submit adequate evidence that said product has been destroyed or recycled.
